Law Enforcement Officer's Safety Act - HR 218
LEOSA Training Information**

YOU MUST POSSESS A PHOTOGRAPHIC IDENTIFICATION CARD ISSUED BY YOUR AGENCY INDICATING THAT YOU ARE A RETIRED OR SEPARATED LAW ENFORCEMENT OFFICER.

WITHOUT THIS ID CARD YOU ARE NOT ELIGIBLE FOR LEOSA.
UPON SUCCESSFUL COMPLETION OF TRAINING/QUALIFICATION A
CERTIFICATION STICKER WILL BE PLACED ON THE BACK OF YOUR
IDENTIFICATION CARD

Read the packet content carefully and in its entirety.

PAPERWORK:

- You must also print and include a photocopy of both your MD Driver's License AND your photo ID issued to you by your respective agency (front and back for both IDs).
- Complete the LEOSA Qualification Application & Affidavit before scheduling a training date.
- Bring all paperwork and a check for the required fee of \$75 made payable to Frostburg State University, with you on your assigned training date.
- Do not mail or bring the paperwork to us, prior to your training date.

If you need to cancel or change the training date, **CALL US!** If you fail to show for a scheduled training appointment without notifying us as stated above, your next training session will cost you double.

PERMITTED WEAPONS:

1. All weapons must have a firing pin block, hammer block system, or other drop safety system. We reserve the right to exclude any weapon or student for safety reasons.
2. If you qualify with a semi-automatic pistol, you will be certified to carry any semi-automatic pistol.
3. If you qualify with a revolver, you will be certified to carry any revolver.

TRAINING INCLUDES:

Approximately two hours of classroom and two qualification courses (one 50 round day fire course and one 30 round reduced light course using dark goggles).

BRING:

Without these items, training will not be conducted and certification not granted.

1. All completed paperwork (3-page affidavit, 2-page waiver of liability and front/back copies of both your MD Driver's License and retired photo ID).
2. Valid Maryland driver's license.
3. Retired photo ID.
4. **Check or money order ONLY** for the training fee of \$75.00.
NO CASH OR CREDIT CARDS ARE ACCEPTED.
5. The weapon with which you are going to qualify.
6. Two magazines for semi-auto pistol.
7. 100 rounds of **American made ammunition** for your weapon.
NO RELOADED OR REMANUFACTURED AMMUNITION, NO FOREIGN MADE AMMUNITION OR ALUMINUM CASED AMMUNITION (Blazer) & NO STEEL CASED AMMUNITION.
8. Strong side holster for each weapon. No cross-draw holsters, ankle holsters or fanny packs allowed.
9. Proper range clothing: shoes or boots, long pants, shirt fastened at the collar, belt to support the holster.
10. Baseball hat or other hat with a brim to keep brass from falling into your glasses.

WE SUPPLY:

1. Eye and ear protection. You may bring your own if you like; prescription glasses are acceptable.
2. LEOSA firearm certification card, good for 1 year from the training date.

REMINDER:

1. If it is raining, dress appropriately.
2. All shooters must be able to kneel down and stand back up on their own. This is a mandated part of police training and FSUPD staff cannot assist you.
