# ACADEMIC PROGRAM ARTICULATION AGREEMENT BETWEEN Allegany College of Maryland AND

Frostburg State University REGARDING TRANSFER FROM Associate of Applied Science in Physical Therapist Assistant TO Bachelor of Science in Exercise & Sport Science

This Academic Program Articulation Agreement ("Agreement") is entered into by and between Allegany College of Maryland (the "Sending Institution") and Frostburg State University (the "Receiving Institution") (collectively, the "Institutions") to facilitate the transfer of academic credits from Allegany College of Maryland's Associate of Applied Science in Physical Therapist Assistant, PTA, HEGIS 5219.01, CIP 51.0806 for the completion of Frostburg State University's Bachelor of Science in Exercise & Sport Science, EXSS, HEGIS 08.35.02, CIP 31.0505, (the "Program(s)").

## A. Qualifying Students

This Agreement pertains to the transfer of "Qualifying Students", i.e., those students who:

- 1. Have successfully completed the program at the Sending Institution;
- 2. Are enrolled in the Sending Institution, in good standing; and
- 3. Are accepted for admission to the Receiving Institution.

# B. Responsibilities of the Institutions

The Institutions agree to implement the transfer of Qualifying Students in accordance with applicable law and the following requirements and protocols:

- 1. A Qualifying Student may transfer into from the Transferring Institution into the Receiving Institution for the completion of the Program.
- 2. Courses that the Receiving School will accept credits for towards completion of the Program include:

\*Students at ACM are required to take *either* BIO 121/201 or 207/208 for the PTA Program. ACM's students are advised to take BIO 207/208 because they will transfer as EXSS major requirements to FSU. ACM's BIO 207/208 sequence requires a prerequisite of BIO 101 (FSU's BIOL 149), which will transfer as the prerequisite for FSU's BIOL 321/322 sequence. ACM's BIO 101 (FSU's BIOL 149) is also required for FSU's EXSS program major requirements.

- \*\* Students at ACM are required to take 2 credits of Physical Education Electives. Students in the PTA program are encouraged to take PHED 153 as those two credits.
- 3. A. Students in the PTA and EXSS programs are required to achieve a grade of C or better in all major courses as well as core GEP requirements (ENGL 101 and MATH 109).

B. The student is required to complete 14 credits of major electives at FSU. Six of those electives will have already been completed with the PTA program as indicated in the table above. If the student chooses to complete the remaining 8 credits of electives at the Sending Institution, it is recommended that he or she choose from the Major Electives listed in the table below. If the student chooses to complete the remaining 8 credits of electives at the Receiving Institution, he or she may choose alternate major electives as listed in Frostburg State University's Undergraduate Catalog. However, a maximum of 70 credits transfer, so students should keep that in mind when choosing where to take their major electives. Additionally, many of the EXSS electives are required prerequisites for DPT (Doctor of Physical Therapy) programs, so if students are transferring in order to eventually pursue a DPT program, they should consult the program of their choice to determine which major electives would also work as prerequisites for the DPT program.

5. If the Qualifying Student is using federal Title 38 VA Education Benefits (GI Bill® Education Benefits), the Institutions shall adhere to all applicable U.S. Department of Veterans Affairs' regulations, including the regulations governing the awarding prior credit, as regulated under Title 38, Code of Federal Regulations, Sections 21.4253(d)(3) and 21.4254(c)(4).

- 6. Each Institution shall adhere to all applicable transfer requirements set forth in the Annotated Code of Maryland and the Code of Maryland Regulations.
- Each Institution shall advise students regarding transfer opportunities under this Agreement, and shall advise students of financial aid opportunities and implications associated with the transfer.
- 8. Should either Institution make changes to program requirements, the institution will inform the partner institution immediately. The articulation agreement should be updated to reflect the changes and forwarded to the Maryland Higher Education Commission.

#### C. Term and Termination

- 1. This agreement shall be effective on the date that it is signed by the appropriate and authorized representatives of each Institution.
- 2. Either Institution may, at its sole discretion, terminate this Agreement upon delivering 60 days written notice to the other Institution and the Maryland Higher Education Commission.
- 3. Both Institutions agree to meet once every 3 year(s) to review the terms of this agreement.

#### D. Amendment

- 1. This Agreement constitutes the entire understanding and agreement of the Institutions with respect to their rights and obligations in carrying out the terms of the Agreement, and supersedes any prior or contemporaneous agreements or understandings.
- 2. This Agreement may be modified only by written amendment executed by both Institutions.

# E. Governing Law

This Agreement shall be governed by, and construed in accordance with, the laws of the State of Maryland.

## F. Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed to be an original, but all of which, taken together, shall constitute one and the same agreement.

### G. Notice of Agreement

1. The Institutions agree to provide a copy of this Agreement, with any amendments, to the Maryland Higher Education Commission.

2. The Institutions agree to provide copies of this Agreement to all relevant individuals and departments of the Institutions, including but not limited to students, academic department chairs participating in the transfer, offices of the president, registrar's offices, and financial aid offices.

# H. No Third-Party Beneficiaries

There are no third-party beneficiaries to this Agreement.

## I. Representations and Warranties of the Parties

Both Institutions represent and warrant that the following shall be true and correct as of the Effective Date of this Agreement, and shall continue to be true and correct during the term of this Agreement:

- 1. The Institutions are and shall remain in compliance with all applicable federal, state, and local statutes, laws, ordinances, and regulations relating to this Agreement, as amended from time to time.
- 2. Each Institution has taken all action necessary for the approval and execution of this Agreement.
