SGA Student Senate Membership Composition Resolution**

**A RESOLUTION CONCERNING:**

**SGA Student Senate Membership Composition**

The Student Government Association seeks to amend the Constitution of the Student Senate to ensure representation of the entirety of the Student Body at Frostburg State University.

**WHEREAS:** The current terminology used regarding "Freshman" students is outdated,

**WHEREAS:** Student Athletes and Commuter Students make up a large portion of the Student Body and it is incredibly important to make sure that every student feels heard and represented.

**THEREFORE BE IT RESOLVED THAT:**

The composition of the Student Senate, prior to the appointment of the Secretary, shall be as follows: twenty-eight (28) at-large students, one (1) transfer student, two (2) first-year students, and one (1) student-athlete, maintaining the total number of seats at thirty-two (32).

**AMENDMENT TO THE CONSTITUTION: ARTICLE VI SECTION A**

The SGA representative body shall consist of a Student Senate. Twenty-eight at large students shall be elected by the undergraduate body. The Secretary shall be appointed from the Senate, reducing the total number of that Senator's constituency by one (1) seat and the total number of seats to thirty-one. Included in the thirty-two seats are ~~one non-traditional student,~~ and two ~~freshman~~ who shall be appointed by the SGA President, with the advice and consent of the Student Senate. The composition of the Student Senate, before the appointment of the Secretary shall be as follows: Twenty-eight (28) at-large students, One (1) transfer student, One (1) non-traditional student, and two (2) freshman students.

The SGA representative body shall consist of a Student Senate. Twenty-eight (28) at large students shall be elected by the undergraduate body. The Secretary shall be appointed from the Senate, reducing the total number of that Senator's constituency

by one (1) seat and the total number of seats to thirty-one (31).  
Included in the thirty-two seats are one transfer student,  
two first-year students, and one student athlete who shall be appointed  
by the SGA President, with the advice and consent of the Student Senate.  
The composition of the Student Senate, before the appointment  
of the Secretary shall be as follows: Twenty-eight (28)  
at-large students, One (1) transfer student, and Two (2) first-year students,  
One (1) commuter student and (1) student athlete.
